Why does my Mortgage Lender need so much information?

Why does my credit union need to know so much about me to grant me a mortgage?

Exhaustive research into the financial, personal and credit history of home loan applicants is not unique to credit unions. Every home lender will request similar information for processing the loan.

Why are lenders so nosy?

Actually, they're not. They're only trying to satisfy the criteria for a protected mortgage, or a Qualified Mortgage. In January 2014, the Consumer Financial Protection Bureau (CFPB) introduced the Qualified Mortgage (QM), a loan category that protects lenders from being forced to buy back a loan if the borrower defaults. To qualify, the lenders must follow the CFPB's guidelines when determining a buyer's eligibility for a mortgage.

Which documents will my lender ask for?

You will likely need to provide the following documents for your lender:

- Financial account statements from the last two months
- Tax returns from the last two years
- A list of your assets
- Your landlord's contact information
- A gift letter from anyone who gave you money to help cover the down payment and closing costs
- Your credit reports
- Recent pay stubs
- Photo identification

What kind of personal questions can I expect?

Each of the following questions can substantially affect your financial standing:

- Have you been through a divorce? If yes, what were the terms?
- Have you ever been involved in a lawsuit — on either side of the bench?
- Have you ever sold a home through a short sale?
- How long have you been employed at your current job?

Stop by any branch to quickly complete the form.



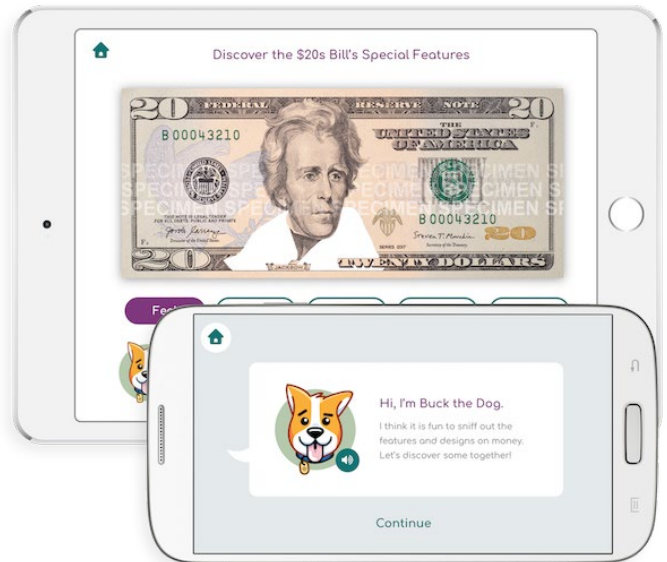


Money Adventure Mobile App

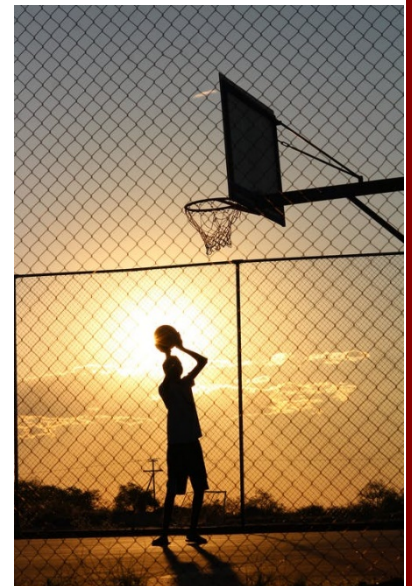
Money Adventure is available for download on iOS and Android devices.
